Dues for the 2018 Season are listed below:

Family Membership

- \$395 if paid by April 2nd
- \$425 starting April 3rd

Teen and Senior Membership

- \$245 if paid by April 2nd
- \$265 starting April 3rd

Payments should be mailed to **Stanley Recreation Club, PO Box 2, Stanley, NC 28164**. Income from dues is needed prior to the pool opening for the club to make needed repairs, pay insurance, and prepare the pool for opening day. We are asking everyone to please complete the application so we can update our records with member's current information.

Starting this year, if you refer 4 new families (not members last year) and they pay their membership dues prior to opening day, you get a family membership for **FREE** (a \$425 value).

Pool Rules: Please take time to review the pool rules with your entire family. If you don't have a copy you may ask for one at the concession stand. As always, the Board has asked the lifeguards and pool management to strictly enforce these rules in order to operate the pool in a safe and orderly manner.



Hours of Operation:

Monday - Friday 11:00 am – 8:00 pm

Saturday 11:00 am – 6:00 pm

Sunday 1:00 pm – 6:00 pm

The pool will be open from Memorial Day weekend (Saturday, May 26th) through Labor Day weekend (Monday, September 3rd). Please note that pool hours may vary in accordance with the Gaston County Schools calendar while school is in session. Hours will be posted on the gate, the website and Facebook during this time.

Visitor Days: Visitor days will be Wednesdays and the first and third weekend of every month (Fri., Sat., and Sun.). In addition, this year we will offer visitor cards again for **\$30**. This card enables members to bring a guest on any day. Each card is good for 6 visits. The cards may be purchased at the concession stand. **There is a limit of one visitor card per membership.** Out of town guests (at least a 15-mile radius away) are welcome at any time. The fee for visitors is \$5 per day, unless a visitor card is being used. **Visitors must be accompanied by a member and must sign a waiver/release form before swimming.** Visitor cards must be purchased by an adult and is property of the pool member.

Baby Sitter Memberships: Baby sitter memberships will be available again this year for a \$50 fee. This membership allows a baby sitter, who is at least 16 years of age, to bring a member's children to the pool without a parent or guardian.

Children at the Pool: Children at the pool must be at least 10 years old and pass a swim test before they may be left at the pool without a parent or guardian. Please consider the maturity level of your child before exercising this privilege. **Swimmers between ages of 10-16 left unattended, must provide an emergency contact name and number of a parent or guardian, in case of an emergency. This policy will be STRICTLY enforced.**

Letter of Intent to Sell: Some older members still own stock membership. If you are one of those members, you must send a letter of intent to sell and it must be postmarked by May 1st. If the letter is postmarked after May 1st, the \$425 dues payment will be subtracted from the sale price of the stock membership. If you did not join at the time when there was stock, please let the pool know if you do not plan to return for the 2018 season.
